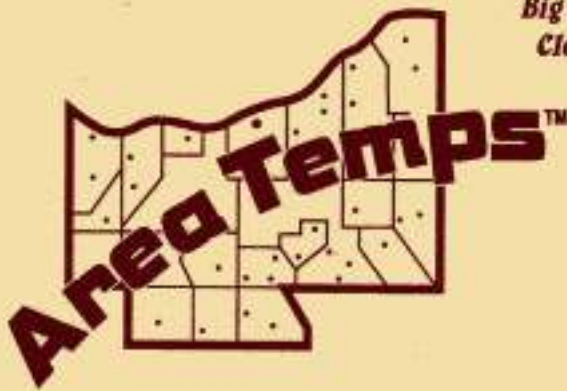


To whom it may concern:

To Whom it May Concern:

I recently had the opportunity to utilize the services of Integrity Investigations. On this particular workers' compensation case, two larger investigatory firms had initially been retained to perform surveillance on the claimant who lives in a rural area. The initial firm sent two investigators out into the field who stationed themselves in their vehicles just north and south of the claimant's residence. They did this for three days and concluded their surveillance with little to show in the way of video or any other kind of results. The second firm had similar results after only two days of attempted surveillance.


After reviewing his qualifications and discussing the complicating factors in this matter, I gave Mr. Baeppler a chance to look at the case. On the day he received the assignment, he traveled an hour and a half to scout the claimant's rural residence out. The following day, he called me to report that he had hiked a mile and half from his car to take up a position from which he could view the rear of the claimant's property where a plowed field and horse barn existed. Additionally, he advised me that he had acquired video of the claimant (who reportedly had a bad back and neck) performing farming activities that were wholly inconsistent with her purported injuries and disability. Further surveillance was ordered and additional investigation undeniably confirmed the identity of the claimant.

This costly and problematic claim was finally brought to a close after the claimant's attorney reviewed the investigative report and video—**The case was withdrawn.**

I would highly recommend Paul Baeppler of Integrity Investigations for any workers' compensation matter where surveillance might be necessary and appropriate. He maintained excellent contact throughout the investigation and prepared a detailed and professional report which was essential to the defense of the claim.
